Shareholders who are entitled to attend the Meeting are given the opportunity to authorize their attendance and voting electronically by using e-Proxy on the eASY.KSEI platform which can be accessed through the website www.easy.ksei.co.id provided by PT Kustodian Sentral Efek Indonesia (KSEI) and pursuant to Article 27 of POJK 15 of 2020, the Company provides an alternative of electronic power of attorney provided by KSEI.

Further information regarding the power of attorney mechanism and other procedures related to the holding of the Meeting will be conveyed by the Company in the Notice of the Meeting.
